

**General Statement of Assurance**

The undersigned party ("Company"), acknowledges that the export, re-export, or import into any other country of commodities, technical data, or software ("Items") that Company has or will purchase and/or receive (directly/indirectly) from FormFactor Inc., or its affiliates, subsidiaries and parent company (collectively, "FF") may be subject to the export/import control laws and regulations of the U.S. and Germany, or any other applicable law where such law does not conflict with the laws of the United States and Germany. - iii. If applicable, licenses or prior approvals required by the U.S. government/German Government will be obtained prior to the export or re-export of FF products, software or technology.
